Mission

To provide a safe space for gay, lesbian, bisexual, transgender and questioning youth in Central Florida.

Impact

The Orlando Youth Alliance works with LGBTQ youth to help them build a positive identity through self-esteem and sense of purpose, build a positive view of their personal future and develop positive adult and peer role models. OYA provides emotional support through a peer-to-peer model, helps youth establish boundaries and expectations, gain empowerment and creates a constructive use of their time. We help our youth strengthen their internal developmental assets of learning, building a positive self image, values and social competencies. Hundred of young people have benefited from their involvement in OYA. The Orlando Youth Alliance is the community gay straight alliance.

Needs

Bullying of lesbian, gay, bi-sexual, transgender and questioning (LGBTQ) youth is at an alarming level. Extreme bullying can torture a gay youth leaving them feeling depressed and alone. LGBTQ youth are three times more likely to commit suicide than their heterosexual classmates. Having a gay straight alliance (GSA) makes a school more accessible to LGBT students by contributing to a more positive school environment. A GSA helps students to identify supportive school staff which has been shown to have a positive impact on their academic achievement and experiences in school. Most students lack access to GSAs or other student clubs that provide support and address issues specific to LGBT students and their allies. There are an estimated 8,000 LGBT teenagers in Orange, Osceola and Seminole County schools. Only a handful of schools have a gay straight alliance to provide help and support. OYA is the community GSA. OYA is so vitally important. With limited fund we help as many young people as possible, but the need is much greater than the funds available. In wake of recent events we provide grief counseling to survivors of the Pulse tragedy. As many of our youth frequented the night club and lost friends.

Background

The Orlando Youth Alliance (OYA) is a non-profit 501(c)(3) organization which provides a safe space for Gay, Lesbian, Bisexual, Transgendered and Questioning (GLBTQ) youth to gather, talk about issues and concerns that are important in their lives, as well as meet other gay youth. OYA is a peer based youth support group with members ranging from the ages of 13 to 24.

The Orlando Youth Alliance was first formed in 1990 as a support group to assist at-risk gay, lesbian, bi-sexual and transgender youth under the moniker "Delta Youth Alliance". The group evolved into "GALIXY", Gay And Lesbian Idea eXchange for Youth. The group exists today as the Orlando Youth Alliance, Inc., (OYA) but maintains the same mission statement.

Through the years, OYA has provided support to hundreds of Central Florida youth. Beyond weekly meetings, the group has expanded its outreach into the Orlando community. Even though the name has changed over the years, the mission has not. We are committed to providing a safe place for GLBTQ youth to gather and be themselves in the self discovery and development phase of their teen years.

In 2008, OYA started a chapter in Polk County called the Lakeland Youth Alliance. In 2010 we started a chapter in Seminole County called the Seminole Youth Alliance. We are in the process of starting a chapter in Osceola and Lake County.

Goals

The goal for OYA members is to increase their knowledge and cultural competence; build a positive identity through improved self-esteem and sense of purpose; build a positive view of their personal future and develop positive adult and peer role models. The program is evaluated using a standard set of questions to qualitatively measure the impact the educational project has on the intended outcomes.

Strategies

We accomplish our mission through three programs:

- 1) A weekly peer-to-peer support group is offered in Orlando on Tuesdays, Lakeland on Wednesdays and Longwood on Thursdays. With the help of criminally background checked adult facilitators the youth help to problem solve and discuss topics such as family and school that are relevant to them. Guest speakers from the community come to talk to the youth on career development, HIV & STDs, bullying and other topics.
- 2) LGBT History & Culture classes are provided to GLBT youth and their straight allies. The one & a half hour sessions will be held once a month during the school year. The students are given homework assignments and report back two weeks later. Since LGBT history & culture is not taught in the school it is imperative that our youth learn about their heritage to develop internal assets such as positive values, social competencies and positive self-identity.
- 3) Meeting other LGBT youth to forge friendships and create a support network is imperative. OYA hosts numerous activities (car washes, movie nights, dances, theme park outings, arts events) to help our youth develop.

Capabilities

Lesbian, gay, bisexual & transgender (LGBT) teenagers are three times more likely to commit suicide than their heterosexual classmates. Since 1990 the Orlando Youth Alliance (OYA) has provided mentoring and support to Central Florida LGBT youth. We are proud to report that of the more than 1,500 youth who have participated in our program -- not a single one has committed suicide. We are an all volunteer organization at this time. We are impacting the youth of our community and creating a true difference even though we are small and all volunteer. Over the past five years we have tripled in size (both in membership and in dollars raised).

Indicators

The main indicator of success is no suicide attempts. But more realistic is the numbers of youth who go on to become productive members of the society and future leaders of tomorrow. An example of one of our youth is now the business manager at a local newspaper.

Progress is shown by the tremendous grow of our organization and the long term success of our youth.

Michael Slaymaker has over 25 years of experience in fundraising and administration of non profit organizations. Michael has raised over \$33 million for charities. He earned his Masters of Arts Degree in Human Resources from Rollins College.

Currently, Mr. Slaymaker is the Vice President of Grants and Planned Giving for Easterseals Florida where he manages the grants funding and planned giving for 40 of Florida's 67 counties. Michael is the Chapter Administrator for the Central Florida Chapter of the Association of Fundraising Professionals.
